1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Government Bikram College of Commerce, Patiala was established in 1945, two years before India became independent. It is a co-educational institution in the field of commerce. It is the oldest Government College of Commerce in Northern India, established by His Highness of Faridkot State, Raja Harinder Singh in memory of his grandfather Raja Bikram Singh. Later in 1955, this institution was relocated to Patiala. Earlier the college was affiliated to Panjab University, Chandigarh. Later on, with the establishment of Punjabi University Patiala, it has been affiliated to Punjabi University Patiala since 1962. The College is a premiere Government institute exclusively for commerce education. It has become a symbol of hope for those young minds with dreams in their eyes who cannot afford expensive education in private institutions.

The college has covered a long journey of about 77 years in a regal style bolstered by the untiring efforts of the teaching faculty and attained achievements in all the fields i.e. Sports, NSS, Academics, Business, Commerce, and Industry.

There are many employment opportunities in the field of commerce such as Banking, Insurance, Audit, Accounts, Company Secretary, Chartered Accountants, Management Accountants, Financial Analysts, Company Law, Tax practice, Marketing, I.A.S, I.P.S., I.R.S., P.C.S, (Civil and judicial services), and teaching . Students passed from this college are appointed on higher posts in many institutions and are spreading the fragrance of the college far and wide. All this has become possible because of the dedicated, highly qualified teaching faculty.

The college has Saheed Bhagat Singh Hall, Seminar Room, Amrita Pritam fully computerized library, smart classrooms, virtual classrooms, language labs, solar panels, silent automatic generators. Digital camera surveillance have also been provided for the purpose of providing better facilities to the students. The Training Placement and Career Counselling Cell in the college makes all the efforts for the placement of students. Undoubtedly, it is a distinguished educational institution in the field of commerce. At present, the college is actively engaged in dispensing knowledge to 1307 students in M.Com (2 year degree course), B.Com (3 year degree course) and BCA (3 year degree course).

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The college, being an affiliated college to Punjabi university Patiala follows the curriculum designed by the parent university. In order to implement the curriculum effectively, the college uses all its intellectual and infrastructural resources. To reflect all the relevant information regarding institutions to the students, College Prospectus is prepared well in advance. The College prepares its own Academic calendar as per the Schedule of Punjabi University, Patiala before the commencement of the Academic session. The college organizes an orientation week for fresh students to acquaint them with the new environment of college campus. Class wise time table is prepared by time table committee in consultation with HODs and the Principal. ICT based teaching learning procedure has also been incorporated along with conventional lecture method to ensure better academic performance. To ensure effective curriculum delivery, Lesson plans are also prepared by faculty members for covering the whole syllabus within time. Apart from assigning assignment to the students, the class tests, class discussions, seminar presentations, house exams (MSTs) are held for the evaluation of the students. Faculty members of this college who are the members of Board of Studies of the affiliating university contribute in designing and updating curriculum. To enrich the curriculum various Co-Curriculum activities like debates, declamations, lecture of experts, seminars and workshops etc. are regularly organized by the college. To develop multi-faceted capabilities among the students three certified courses and one certified programme are offered by the college. During the Covid period online teaching had been carried out. The critical issues related to professional ethics, gender human values and environment sustainability are an integral part of teaching and learning process and are also addressed through various co-curriculum activities. The curriculum includes one optional subject Office Management and Secretarial Practice at undergraduate level which involves the experiential learning to entail the project work, field work and internship for the students. College also takes feedback from stakeholders like students, alumni members, teachers, parents and takes all

corrective steps to further improve the curriculum delivery.

Teaching-learning and Evaluation

Govt. Bikram College of Commerce, Patiala follows a transparent and systematic admission policy which is effectively publicized through the College Prospectus, College Website and other well devised mechanism formulated for the same. The admission process adheres to Punjabi University, Patiala, UGC and State Govt. Norms. All the admissions are merit based and done through the centralized Govt. Portal. The excellent mentor-mentee system of the institute takes care of academic and stress related issues. Academic-Calendar and lesson plans are strictly followed and are audited regularly. Most of the faculty members are with Ph.D. qualification and a good number of faculty have an experience of more than 15 years. The well qualified and research oriented faculty provides various opportunities for experiential, practical, participatory and problem- solving learning methods through workshops, seminars, guest lectures, group discussions, field visits, educational tours, audio-visual aids, internships etc. The College always aims to provide up-to-date ICT infrastructure for faculty and students. A well-equipped open access computerized library with internet facility is available for faculty and students. Regular workshops are conducted by the college administration for the faculty and students to provide training for the use of ICT. The programme outcomes and course outcomes are formulated to achieve academic excellence, research potency and human values among students. POs, PSOs, COs are displayed for all stakeholders at Institution's website. The college has an effective mechanism to measure evaluation and attainment of POs and COs by using various indicators throughout the academic year. Feedback on attainment of POs and COs is used as a reliable assessment tool for appraising the reach in the attainment of POs and COs and implement revision. It is ensured that each student is benefited from the course learned with respect to its stated outcome. Moreover, students securing university ranks, progressing for higher studies, securing employment, qualifying state and national competitive examinations, having achievements in sports and cultural activities have also been visible pointers used to determine the successful rendering of POs and COs. Link ups through MOUs, industrial visits provide the much needed exposure and hands on experience to our students.

Research, Innovations and Extension

Research and innovations are integral to education and they provide much needed reformative boost to the present ongoing system. Extension is another area which connects a higher educational institution with the society. The research efforts of the college faculty is based on their individual initiatives as no major grants are earmarked for research endeavours and no separate financial corpus is available in the college for this purpose.

The faculty of the college has published 162 research papers related to different disciplines in various reputed journals and also 39 books and 08 chapters in authored books from year 2017 to 2022. Various clubs, committees, along with NSS unit of the college are conducting extension and outreach activities. They celebrate days such as Independence Day, Gandhi Jayanti, World Environment Day, AIDS Day. Different departments also organize field trips for the students to give them field experience and practical knowledge outside classrooms. Training Placement and Career Counseling Cell and Red Ribbon Club etc. of the college have also been working effectively to provide counseling to students regarding various career prospects and raising awareness about HIV/AIDS.

Even during the COVID-19 pandemic, students actively participated in various activities conducted online. The faculty and students have also received appreciation for different activities in the form of certificates and letters.

The college has also signed MOUs with other reputed institutions to increase the job prospects of students.

Infrastructure and Learning Resources

Govt. Bikram College of Commerce, Patiala is committed to provide an inclusive holistic education system in sync with the changing times. The comprehensive infrastructure of the college is constituted by elementary features like buildings, classrooms and playgrounds, and advanced attributes like ICT-enabled classrooms, departments and laboratory facilities. The Library of the college is updated regularly with the latest books and journals and is fully automated using KOHA and SOUL. Book bank is one of the special and important features of the library, as through book bank needy students get the library books issued for the whole session/ semester.

Students regularly take part in the cultural activities, inter-collegiate, inter-university state level and national level competitions under the guidance of Coordinator, Youth Welfare and won prizes. The mega sports event Annual Sports event is conducted in the institute where several teams participate. The college has three fully equipped modern Wi-Fi Computer Labs consisting of 124 computers with ICT facilities. One Vocational Lab is also provided for the Office Automation and Secretarial Practices. There is one Language Lab consisting of 22 N Computing and one server facility which caters the needs of students for improving Spoken English.

The college has one seminar hall and one multipurpose hall with ICT enabled facilities to conduct academic and nonacademic activities. The students are provided other amenities like Campus Wi-Fi, hostel facility, transport, medical and surveillance cameras, solar panel, un-interrupted supply of power through Genset, drinking water-coolers with R.O. facility, first aid and canteen facilities.

Student Support and Progression

Most of the students i.e. around 90 percent of Govt. Bikram College of Commerce, Patiala receive scholarships and freeships provided by Govt. and Non-Govt. Agencies which include National Scholarship, Minorities Scholarship, and Scholarship for students with Disability provided by Central Govt., whereas SC, BC Scholarships and Concessional Bus facilities are provided by the Govt. of Punjab. In addition to this Tuition Fee Concession for under graduate girl students are also provided by state Govt. Alumni of the College also help the needy students. For capacity building and skill development the College organizes Lectures, Seminars, Workshops, Camps, Educational Tours and other extracurricular activities. Our College also provides guidance for competitive exams and career counseling. For this purpose the College invites several companies to visit the campus for placements. Through the guidance of placement cell many of our students crack UGC (NET), IELTS and many State Govt. exams. Many of our students pursue higher studies after graduation and post-graduation in India and abroad. Our many students join jobs or family business after completing their studies from this institute. Our students not only excel in academics but also participate and win positions in sports and cultural activities organized by college, other institutes and university. The College has an efficacious and successful Grievance Redressal Mechanism, consisting of redressal committee that focuses on careful and sensitive handling of student grievances. The institute has an Alumni Association known as Bikram Alumni (Global) Association which is a registered body. The Alumni body holds meetings from time to time, evolves policies regarding the working of the association. Annual reunion of alumni is held every year.

Governance, Leadership and Management

Institution has well defined vision and mission and focuses on holistic development of students. Effective leadership is reflected in values and decision making for attaining the outcomes of set objectives. Our administrator has got the appreciation letters from higher authorities for contributing towards increase in GER and CA results.

There is participative culture and decentralization of work through the formation of various committees. IQAC plays an important role in involvement of different stakeholders in policy making and its implementation for the Institutional Development Plan.

Use of e-governance in administration, finance and accounts, student admission and support as well as examination is in operation. The institution is a Govt. Institution so Punjab Govt. service rules are applicable for all the cadres. Self-appraisal form, prescribed by Higher Education Department and PBAS-Performance Based Appraisal system laid down by UGC is implemented for evaluating the faculty covered under the guidelines. Different welfare schemes for teaching and non-teaching staff members are available as per Punjab Govt. rules. Budget is properly utilised as per prescribed guidelines, rules and regulations of Punjab Govt. Institution regularly monitors effective utilisation of financial resources. Internal and external audits are carried out to verify accuracy.

Quality Assurance policies are designed, implemented and reviewed by the Internal Quality Assurance Cell (IQAC) through a feedback mechanism, besides giving participation to students as members of various administrative committees. The society inputs are obtained through parent-teacher meetings, HEIS meetings and Alumni Association meetings. Response:

The college is affiliated to Punjabi University, Patiala follows the curriculum designed by the parent university. A well planned and documented process has been developed by the college for effective and timely delivery of curriculum.

- College Prospectus is prepared in advance. It reflects all the relevant information regarding institution.
- College prepares its own Academic calendar as per the schedule of Punjabi University, Patiala before the commencement of the session. This academic calendar is displayed on the notice board and uploaded on college website.
- The college organizes an orientation programme for new students to acquaint them with the college environment.
- Syllabus link for each class is available on the college website as well as in the college, Amrita Pritam Library.
- Time table committee has been constituted that prepares the time table at the beginning of the session in the consultation with Head of the Departments and the Principal which is displayed on the notice board and put in students' WhatsApp group.
- Proctoral duties are assigned to the faculty members to maintain discipline in college campus.
- Allocation of subjects is done by HODs as per U.G.C. and University norms after considering the interest, specialization and expertise of faculty members.
- Lesson plans are prepared by the faculty members for covering the whole syllabus within time which are reviewed by the college Principal.
- Assignments are assigned to the students on the basis of current topics related to their respective field of study.
- Mentors are assigned to each section of every class who redresses the grievances of the students.
- 75% attendance is a pre-condition for each course. So, Attendance Register is maintained by the teacher.
- Various pedagogical techniques like class test, class discussion, seminar presentation, house exams (MSTs) are held for evaluation of students.
- Every course in each semester constitutes 30 percent of total marks as internal assessment which is based on 40% house exam marks, 40% assignment and 20% class performance & attendance. All the records are maintained by the House Examination Registrar.
- Co-Curricular Activities like debates, declamation, lecture of experts, seminars, workshops, industrial visits, project works, educational tours, sports, NSS and cultural activities are organized by the college in every semester.
- ICT based teaching learning procedure has also been incorporated along with conventional

lecture method to ensure better academic performance.

- During the Covid period online teaching was carried out. E-content in form of PDF files and Word documents were also shared with students.
- College also takes feedback from students, alumni, teachers and parents to improve the curriculum delivery.

2.3 Teaching- Learning Process

2.3.1

Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences and teachers use ICT- enabled tools including online resources for effective teaching and learning process

Response:

The student-centric methods like experiential learning, participative learning and problem-solving methodologies are used to make the learning process more effective. ICT enabled tools and resources are used for effective delivery in the classrooms as well as in computer labs. Invariably, the lesson plans to deliver a specific course is prepared in advance. The subject teacher decides the topics to be covered using smart boards for the effective delivery of the content by the teacher and effective learning on the part of students. The subject teacher uploads the lesson plan in advance to the WhatsApp groups wherein he/she specifically mentions the mode of delivery as 'Chalk and Talk, PPT or Video Lectures in the Smart classes. Google classroom and WhatsApp groups also enable the teacher to upload notes in pdf format, power point presentations and URL or links of video content.

Prior to discussion of some important topics that involve comparatively greater level of understanding and precautions, videos from appropriate sites are shown and explained to the students. Students attain language skills using language lab and use e-resource library for research and knowledge.

An unprecedented rise in the use of ICT based learning and evaluation during the lockdown due to global pandemic COVID-19 has been observed worldwide. The College has also adopted this global change and conducted all the classes in online mode using ZOOM platform, Google classroom, WhatsApp etc. Well framed time-tables, the links for scheduled online classes etc are shared through WhatsApp groups. Assignments and Tests conducted in online mode were sent through google classroom and evaluations were returned through same mode. Regular educational trips, ground surveys, industrial and field visits and real-life case studies offer an immersive and participative learning process to the students.

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

The college is affiliated to Punjabi University Patiala, so the college is obliged to implement all directives of the affiliating university regarding continuous internal evaluation.

Methods of Internal Evaluation:

1. Mid semester tests
2. Assignments and class test
3. Attendance
4. Seminars and group discussions

Mechanism of Internal Assessment and Transparency in Evaluation.

The College has a well established 'Registrar House Examination office' to manage the internal examinations that are conducted during each semester. The Principal through the IQAC and Registrar House Examination of the college monitors the effective implementation of the schedule. The college adheres to the factor of student attendance in all assessments, which serves as an incentive for regularity and academic discipline. The collected assignments, seminars, project reports etc. are evaluated by the teaching faculty. The faculty evaluates the answer sheets within a week of conduction of exams. The evaluated answer sheets are shown to students in class. A well framed criterion as given by the University is maintained to channelize internal assessment in the courses which constitutes 30% weight age. Internal assessment is based on

1. **Performance in two midterm exams – 12% weight age of total marks:** Better of two Mid Semester Tests to be taken
2. **Assignment/ Project work etc. – 12% weight age of total marks**
3. **Class participation/Performance/Snap test – 6% weight age of total marks:** Classroom teaching involves judging the ability, progress and growth of the students through class tests, assignments and group discussions.

It is mandatory for the students to attend 75% lectures. The college conducts university exams as per the guidelines of parent university. The duties of superintendents, invigilators and other supporting staff are deputed by the college as assigned by the university. The college also contributes in the university examination evaluation centre if such duties are assigned by the university.

Mechanism for Internal/External Examination related Grievance: The mechanism is transparent, time bound and efficient.

Grievance Redressal for Internal Examination

Procedure for lodging the complaint:

1. Students can approach to their subject teacher.
2. Students can personally approach or put up a grievance in writing to the Registrar of House Examination or In-charge of Grievance Redressal Committee.
3. Students can also drop their grievance in the complaint box.

Procedure for solving the complaints:

1. Committee reviews all the cases depending on the nature of issue and tries to resolve the issue as early as possible.
2. Committee forwards the same to the concerned person for redressal.
3. Students are informed after taking necessary steps.
4. The whole process remains transparent.
5. The committee assures that the grievance has been properly solved in a stipulated time limit.

Grievance at University Level:

1. The rechecking and revaluation forms are available online, students can apply for it through College.
2. University provides provision for re-evaluation within 15 days of declaration of result.
3. University also provides a provision of re-appear if the student has more than 20% marks.
4. Special chance to appear in the exams is also provided to the students in case of any emergency.
5. If the question paper is out of syllabus then corrective measures are taken by the university in the form of grace marks or re-conducting of exams.

The College has an effective mechanism to measure attainment of POs and COs by using various indicators throughout the semester of the academic year. Continuous evaluation is followed to analyze the attainment levels of POs and COs both for UG and PG programmes. Increase in gross enrollment ratio (GER) in the last two years is an indicator of successful attainment of POs and COs. The institution identifies the slow learners and grooms them to come to the level of other students so that the attainment level of POs, PSOs and COs is raised to the optimum level for each student. The faculty members of all

departments record the performance of each student. Teachers give assignments to students, conduct University End Semester Examination, projects and viva-voce in order to assess the students' performance throughout the academic session. The College puts special efforts by training the students in all round personality development, cultural and social activities. The emphasis is given on the holistic development of students. Feedback on attainment of POs and COs is used as a reliable assessment tool for appraising the reach in the attainment of POs and COs and implement revision, where ever it is required. Feedback on Curriculum is also collected from students and other stakeholders. It is ensured that each student is benefited from the course learned with respect to its stated outcome. Moreover, students securing university ranks, progressing into higher studies and prospective careers, qualifying state and national competitive examinations, having achievements in sports and cultural activities have also been visible pointers used to determine the successful rendering of PO's and CO's. Each department ensures proper documentation of student progress to gauge the level of attainment.

High demand for the courses in the college and a cut off of 91.4% at the entry point of B.Com course in 2022-23 is a significant pointer indicating achievement of PO's and CO's. Appreciation awards to the college from the Office of Higher Education, Chandigarh and huge number of merit positions in all the classes also indicates the attainment of PO's and CO's.

Response:

The college is working with the higher goals of overall development of students so that they may prove an asset for the society. The teachers involve students as active partners in teaching-learning and other co-curricular and extra-curricular activities. They provide students an environment to come out with their innovative ideas and understand the practical exigencies of their respective academic domain. Students are initiated to become curious about the subtler aspects of the prescribed syllabi related topics. They are so groomed that the knowledge leash created in them over a period of time will help them in their career growth.

The teachers provide thorough contextual information related to the syllabi topics and students are asked to search the current developments on these topics. The teachers take keen interest in providing students' comprehensive knowledge and making them reliant in their chosen subjects. The capabilities of students are sharpened by involving them in class participation, presentations, explorative query sessions and friendly counseling. Students are so groomed that they become adept in making use of their learned capabilities in their career and life after their studies. They are so educated that they can see their responsibilities towards the society and take upon themselves a pious duty to transfer their learned knowledge for the betterment of the society. NSS units, Red Cross unit and Legal Literacy Cell of the college guide students in inculcating the spirit of social work.

Thus, this environment helps in grooming students to think rationally, innovatively and creatively to develop their own systematic understanding and to add new dimensions to learning. Outcomes of Extension activities in the neighborhood community in terms of impact and sensitizing the students to social issues for their holistic development during the last five years.

Response:

NSS Unit of the college and various clubs like Red Cross unit, Red Ribbon unit and Eco club are carrying out extension activities in the neighborhood community. Every year, days having national importance such as Independence Day, Republic Day, Gandhi Jayanti, Constitution Day, World Environment Day, AIDS Day, International Yoga Day, International Women's Day, Rashtriya Ekta Diwas, World Water Day, World No Tobacco Day etc. are celebrated with enthusiasm by the college in order to make the students realize the relevance and historicity of these days.

Campaigns on road safety, drug abuse, environment conservation, anti-female foeticide etc., are conducted by the college to familiarize the students with these social issues and sensitize the local community about the same.

NSS unit of the college adopted village of Ablowal under Swachhta Samaroh, Swachhta Pakhwara and Swachh Bharat Summer Internship Program and has been conducting a number of extension and outreach activities such as cleanliness drives, plantation drives, Door to Door Awareness Rallies, Nukkad Nataks etc. so as to make the students socially responsible and contribute back to the society in a substantive manner. NSS unit of the college also celebrates Rashtriya Poshan Maah in September to ensure community mobilization for addressing malnutrition amongst young children and women.

NSS unit also organized various summer and winter camps in which volunteers visited Pingla Ashram, Sanour to provide community services and distributed medicines, medical kits, fruits and sanitary pads to needy person besides spreading awareness regarding sanitation and hygiene. Such initiatives have contributed significantly to transform the mindset of the local youth.

Besides these activities, the NSS unit of the college also organized blood donation camps. Different departments also organize field trips for the students to give them field experience and practical knowledge outside classrooms. The Training, Placement and Career Guidance Cell organizes lectures, seminars etc. to provide guidance to students in exploring various career avenues and application based knowledge. College has been working as a catalyst in the town by showing its institutional responsibility towards society and proven its mettle over and over again by encouraging students to participate in different NSS camps and various cultural and literary activities.

Infrastructure The Infrastructure of the institution is to ensure adequate facilities to provide conducive academic environment for effective teaching-learning and holistic development of students, strengthening its infrastructural facilities according to the functional and growing needs of the institution. Being a Government College, the Government has been constantly infusing adequate capital to support teaching learning process.

1. Classroom Facilities

- 22 well-furnished, spacious classrooms including 11 ICT facility which are also well illuminated.
- In addition, 5 laboratories also serve the dual purpose of lab as well as classroom for small student strengths, all of which are ICT enabled.
- The classrooms are equipped with adequate furniture, blackboard, projectors, fans, lights and power backup.
- The learning spaces are well-ventilated and adequately furnished.

2. Library

The institution recognizes the importance of the library as a good learning resource. It is updated regularly with the latest books & journals. Library is fully automated using KOHA and SOUL (Software for Universities Libraries) version 2.0, SOUL 2.0 is a state of art integrated library management software designed and developed by the INFLIBNET centre based on the requirements of college. The e-resource center is established in the college library.

3. Cultural Activities

Besides academic pursuit, we encourage students to achieve all round personality development. The college has a cultural committee. Every year, our students participate with full fervour and zeal in all activities like giddha, group shabad, group song, folk song, quiz, debate, elocution, poetical recitation, fine arts (painting, poster making, collage etc.) and music competitions at the Youth Festivals of different Universities.

4. Sports

6. Vocational Lab

One Vocational Lab is also provided for the Office Management and Secretarial Practices.

7. Language Lab

There is one Language Lab consisting of 22 N Computing and one server facility which caters the needs of students for improving Spoken English.

8. Multipurpose and Seminar Halls

The college has one seminar hall and one multipurpose hall with ICT enabled facilities to conduct academic and nonacademic activities.

9. Other amenities

The students are provided other amenities like Campus Wi-Fi, hostel facility, transport, medical and Canteen facility, surveillance cameras, solar panel, un-interrupted supply of power through Genset, drinking water-coolers with R.O. facility, first aid and canteen facilities.

Library is automated with digital facilities using Integrated Library Management System (ILMS), adequate subscriptions to e-resources and journals are made. The library is optimally used by the faculty and students

Response:

Library

The library is housed in a spacious building of the college with adequate teaching learning facilities. Library is an organized collection of information resources made accessible to its members. The Library occupies a prominent position; it is an integral part of the teaching program. It is a treasure of knowledge and wisdom. College Library is meant for helping students and teachers to acquire knowledge. The basic function of college library is to assist its parent body to carry out its programs.

The Library of Govt. Bikram college of Commerce, a Professional College is situated in a separate Building. It covers the area of 3200 sq.ft. (297 sq. mts.) Library has a collection of 18,037 books. It

subscribes 10 newspapers (English, Hindi and Punjabi), 25 Journals related to Commerce and Management, Economics, Computer Science, Higher Education and General and Competitive magazines.

Library has a seating capacity of 80 students. Library is partially automated with the Software SOUL 2.0 from INFLIBNET (an Inter-University Centre of UGC) SOUL 2.0 upgraded and with KOHA Software (ILMS) and data of 18,037 books integrated. Most of the Collection is computerized. OPAC (Online public access catalogue) is available for searching the books. Books are being Bar Code. Printed Magazines and journals are displayed in Magazine stand for use. Open access system is followed for books also. Old volumes of Academic Journals are bound for Reference and Research purpose. B. Com, BCA students are entitled to get three books and M. Com & MSc(IT) students four books respectively issued on his/her name for a period of not exceeding 14 days.

Along with the Printed material, library subscribes to E-resources through N-List Programme of INFLIBNET which provide access to about 8 Lacs e-books and 6000+ e-journals. For remote access of N-LIST passwords are issued to Faculty and Students. Internet and reprographic services are also available in the Library.

Book bank is one of the special and important features of the library, as through book bank needy students get the library books issued for the whole session/ semester.

Reader's Club has also been formed to promote reading habits in the staff and students. The College has also instituted '**Best Library User Award**' to the students of under-graduate & post-graduate classes, who has made extensive use of the library during the session and the selected students were conferred a Merit Certificates on Annual Prize Distribution Function.

As per the directions of Directorate of Higher Education all Library functioning has been performed on the recommendation of Library Advisory Committee. Recently BALA work (Building as Learning Aid) has been carried out.

RO Drinking water and clean washroom facility is available adjacent to the Library building for students.

1. Mechanism for Updating IT Facilities

The College has well established mechanism for upgrading and deploying Information technology infrastructure. The IQAC of the college takes feedback every year from the IT faculty of the college on the existing IT facilities, quality of services and future requirements. After reviewing this report, necessary actions are recommended to the college administration. The college has been making consistent efforts to improve upon IT infrastructure and facilities as per the requirements and makes budgetary provisions accordingly. As per the requirement of the maintenance of the above IT equipment, college has faculty and technical staff in Computer Science and Computer Applications departments which use their skills to update and repair the equipment. However, for major disorder and damage, computer technicians and service providers are hired for the up keeping and replacement. The steps like installation of anti-virus periodically, formatting of computers on the basis of corrupt operating system and replacing of hardware of old computers to new computers are taken for maintaining and utilizing computers with License Software.

2. ICT Enabled Classrooms

There has been a paradigm shift in technologies and teaching aids (Blackboard to Green/White board to

internet enabled smart interactive board, Print material to electronic (E-books and other resources) material. The college has updated its IT infrastructure by making 11 classrooms ICT-enabled with smart-interactive panels or projectors to cater to the needs of the students ensuring effective and outcome based teaching-learning.

3. Upgradation of Internet Connectivity

All the ICT-enabled facilities have been connected with Internet via LAN/ Wi-Fi so that faculty while teaching can access Internet for deeper and wider knowledge. Internet speed of 200 mbps data 3300 GB Bharat Fiber FTTH Plans (BSNL). LAN connectivity improved with campus wide LAN networking. Every department has separate computer systems with Wi-Fi facility.

4. Website Updation

College has dynamic website with various interactive links. College website is regularly updated by faculty of computer department.

5. Upgradation of ICT Infrastructure

- The number of computers were increased from 112 to 124 as on date.
- The College also has a Language Lab with audio- visual facilities and license software for English language teaching and learning.
- The college library has been automated and e-resource centre upgraded with more computers. CCTV cameras are installed in college campus at various locations for monitoring and surveillance purpose.
- Latest printers and heavy-duty scanner are available for speedy printing of the documents maintaining quality.
- The Administrative offices have been provided improved hardware and software supports so that the connectivity is seamless.

Further, the college alumni association holds annual get together named as “Home Coming” in the month of December. Not only they discuss about the problems but also help the college to overcome them. They contribute generously and genuinely towards any kind of need of students for instance they have provided several scholarships for students in need, contributed 7 split air conditioners (AC) for Shaheed Bhagat Singh Hall. Moreover the association provided around 20 ceiling fans for classrooms, 25 steel dustbins for classrooms, six office chair for Alumni office, one water cooler with R.O. and water trouff along with shed in collaboration with Rotary club and faculty. The Association has also renovated college gate, decorated boundary wall with theme paintings. Alumni members sponsored open gym and college prospectus in 2022-23. Association also provided funds for landscaping in front of Multipurpose Hall and hedging of lawn adjacent to cycle stand. Total number of life members/patrons of association is about 400.

6.2 Strategy Development and Deployment

6.2.1

The institutional perspective plan is effectively deployed and functioning of the institutional bodies is effective and efficient as visible from policies, administrative setup, appointment, service rules, and procedures, etc

Response:

The hierarchy of organizational structure: The college is governed by the Principal in the administrative setup and under the guidance of Directorate of Higher Education, Punjab. The Principal administers the college and is assisted by teaching and non-teaching staff. The teaching staff in each department is headed by the senior most faculty member who is HOD. Library remains under the control of librarian respectively with overall supervision of Principal. Library Advisory Committee plays a crucial role in the development of library. The institution is using e-office under E-Governance Project of Punjab Government. Non-teaching staff members discharge their duties in the establishment section, accounts section and library. Establishment section is run by superintendent, junior assistant, clerk and steno. Library restorer comes in group C while Group D employees include watchman, gardener and sweepers who bestow their duties diligently. Besides this hierarchical set up, there are numerous committees headed by a convener to support the college operations. Convener can delegate decisions in his/her standing committee under the overall supervision of the chair.

The recruitment of permanent teaching faculty is by Punjab Public Service Commission (PPSC) and permanent non-teaching staff is by Punjab Subordinate Service Selection Board (PSSSB). The service rules of the teaching and non-teaching staff are reflected in CSR and by regulatory bodies of the Government. These service rules are pre-defined and are applicable for any cadre or post. For teaching staff, UGC regulations are applicable in addition to state regulations and for non-teaching staff state regulations are applicable.

The College has a well-prepared strategic plan to fulfill academic development, the infrastructural requirements, curricular and extra-curricular activities. The targets have been set up with the extensive consultation with all the stakeholders including faculty, students, parents, alumni and industry. The development plans have resulted into the creation of best infra structural facilities like creation of ICT enabled new smart class rooms, up-gradation of old class-rooms, vocational lab and language lab, open gym, renovation of sports room and gym room, building as learning aid (BALA) work at Amrita Pritam Library etc.

E-resource center and reading rooms facility is there with rich collection of books, journals, magazines and newspapers along with internet facility for overall grooming of the students. The three NSS units of the college play a crucial role in community outreach programmes. Different facilities required by students and staff are always prioritized in consultation with IQAC. Other initiatives include ramps for differentlyabled students, girls' common room, seminar hall, Shaheed Bhagat Singh hall, canteen and pantry.

At GBC, Holistic Development motto is the guiding principle behind our effort to strive, outshine and achieve distinction. It is a matter of pride that the leader of the institution has been awarded appreciation letters by higher authorities for remarkable increase in GER (Gross Enrolment Ratio) and excellent performance of 51 students in qualifying CA foundation and Inter examination. Two of our faculty members have registered their 15 patents. The college has created its existence on social media platforms like Instagram, YouTube, Face Book and Twitter.

6.3 Faculty Empowerment Strategies

6.3.1

The institution has performance appraisal system, effective welfare measures for teaching and non-teaching staff and avenues for career development/progression

Response:

Welfare Measures for Teaching and Non-Teaching Staff

As the college is a Govt. college so all the welfare schemes in the institute for teaching and non-teaching staff are as per Punjab Government guidelines from time to time. These schemes include new pension scheme (NPS), general provident fund (GPF), general insurance scheme (GIS), leave travel concession, medical reimbursement, loan from banks, dearness allowance, child care leave, travelling allowance, house rent allowance, medical insurance/allowance, mobile allowance, duty leave, earned leave, half pay/medical leave, paternity leave, maternity leave, gratuity, pension, loan from G.P.F. Besides this any medical facility covered under any govt. scheme is also available.

Moreover, different types of leaves can also be availed as and when required in accordance with the rules. Open gym facility, use of refrigerator, microwave ovens and pantry is also kept at the disposal of teaching and non-teaching staff. Celebration of Women's Day in Shaheed Bhagat Singh Hall infuses the spirit of women empowerment where the women staff which is 90% of the total staff is felicitated by the Principal.

Performance Appraisal for Teaching and Non-Teaching Staff

The institute has well-structured performance appraisal system for teaching as well as non-teaching staff. For permanent teaching staff Self-Appraisal Form prescribed by Directorate of Higher Education Department, Govt. of Punjab is filled by them. It is evaluated by Principal of the college. This is further reviewed by the Director Higher Education and accepted by the Education Secretary. College is following the PBAS- Performance Based Appraisal system laid down by UGC for evaluating the faculty covered

under the guidelines. Performance based appraisal system focuses on teaching, learning and evaluation, co-curricular, extension and professional development, research publications and academic contribution related activities. Academic performance index (API) scores are calculated for each category by faculty members for submission of their cases for next grade which are further evaluated by Directorate of Higher Education, Punjab in coordination with concerned university. The faculty members also submit self-appraisal report in the form of Annual performance report (APR's) in the prescribed proforma at the end of every academic year which is evaluated by the Principal of the college and later on the same is reviewed by the higher authorities. The teacher maintains records of teaching, examination and evaluation of the student, record of different concerned committees of the college, research and publications to calculate API scores and the same is then filled in the API. These API are considered for clearing probation as well as for next placement of the faculty. Before placing the staff to next higher grade, the evaluation of APRs by the Principal and acceptance from the Director Colleges Higher Education department is must.

The non-teaching and office staff are also assessed on their work performance and contribution at par with other working staff of the college where they have to fill a Self-appraisal form. This form consists of data mentioning their personal details, duties assigned to them, performance report, and evaluation report by superintendent and also the comments of the reviewing officer.

6.4 Financial Management and Resource Mobilization

6.4.1

Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/ nongovernment organizations) and it conducts financial audits regularly (internal and external)

Response:

The college has well established mechanism for mobilization and optimal utilization of its financial resources. The means for financial resources include:

1. Budget Grant:As per the demand of the institution, budget to the college is allocated by the Director, Higher Education under different heads like salaries, medical reimbursement, electricity charges, office expenses, telephones expenses, domestic travel expenses, other charges etc. It is properly utilized as per prescribed guidelines and govt. rules and regulations.

2. Fee and funds from students: Admission fee and funds are collected from the students during semester admissions as per Punjab Govt. and Punjabi University, Patiala norms. These funds include college development fund, red-cross fund, environment fund, health fund, college sports fund, NSS fund, dilapidation fund, amalgamated fund, student aid fund, magazine fund, Id card fund, house examination fund, building fund, library development fund, electricity-water fund and PTA fund. These funds are further mobilized and utilised for the welfare of students.

3. Infrastructure Grant under RUSA scheme: Rashtriya Uchchar Shiksha Abhiyan (RUSA) Grants are utilised for Infrastructural development under the head Infrastructure Grant to Colleges for new construction, up-gradation and equipment components. Besides this Equity Initiative Component Grant and Management Monitoring Evaluation and Research Grant (MMER) are also utilised for raising excellence and promoting equity.

4. Financial support from UGC: The college is recognized under section 2(f) and 12(B) of UGC. The

funds released are utilized according to the UGC plans submitted.

5. Grant from Higher Education Department under various components: Grants from government for infrastructural facilities are received from Punjab govt. under various heads. The college has constituted different committees for effective utilisation of these funds.

6. Rent received: Income is generated by letting out Shaheed Bhagat Singh Hall to other organisations for their different events as well as the college building for conduct of papers by bodies like PPSC, CMA, ICAI etc.

Punjab Govt. Financial Rules are strictly followed and expenditure is incurred in a transparent manner. All the purchases above Rs. 50,000 are made through E- tendering/ GeM/ DGSD. The financial transactions are cashless because payment is made through cross cheques, bank drafts, RTGS, NEFT and PFMS. The concerned committees ensure utilization of sanctioned grants for different projects as per the codal procedures.

The bursar of the college conducts internal audit of the college funds and other grants received from time to time. Stock registers and cash books are properly maintained. Physical stock verification of all the departments is also done at the end of the year.

The external audit of all government grants or other grants along with audit for all the students' funds is carried out by the Auditors of Finance Department, Govt. of Punjab from time to time. The last audit was done in the year 2020. The College complies with all the suggestions/objections of the auditors. Approval of executive committee is a pre-requisite for the utilization of PTA and HEIS funds. The College gets statutory audit of all PTA funds, HEIS funds, RUSA grants and UGC grants by chartered accountant.

6.5.1

Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes. It reviews teaching learning process, structures & methodologies of operations and learning outcomes at periodic intervals and records the incremental improvement in various activities

Response:

The Internal Quality Assurance Cell of the college is pivotal in planning and execution of different action plans and has contributed significantly in improving the teaching learning environment along with

overall grooming of students by taking new initiatives as well as refining the existing practices. In the whole process for assuring quality in teaching learning process, it involves chalking out of new goals for every academic session in the beginning and effective implementation of the same during the session.

IQAC reviews the teaching learning process, structure and methodologies of operation and learning outcomes on regular basis in a systematic way. Periodic meetings of IQAC coordinator along with IQAC members with HODs and other stake holders are carried out to review the functioning of the college. The focus always remains on the core agenda of teaching learning process, its evaluation and implementation. Feedback collected from students, staff, alumni and other stake holders is analysed. The outcome of the deliberations is discussed with stake holders for their implementation under the overall supervision of principal in coordination with IQAC. The cell has ensured all such efforts by following a well-defined mechanism for achieving academic and administrative excellence. In the beginning of every session the future Institutional development plan is prepared keeping in view different requirements and their importance for effective implementation of steps required for teaching learning process. It includes teaching pedagogy, teaching learning outcomes, infrastructural requirements, evaluation process and role of ICT in grooming of the students besides other initiatives as per their requirements. For fulfilling the students' aspiration in terms of teaching learning process number of initiatives have been taken by college administration in consultation with IQAC. It includes upgradation of ordinary class rooms to smart class rooms with all ICT facilities, focus on adoption of innovative strategies for improving the academic and administrative efficiency, focus on best practices, their analysis and outcomes, use of innovative teaching ideas and brain storming sessions for students, involvement of students as ambassadors, improved library facilities with high-speed internet and access to e-resources and other books, faculty development programmes for teachers and students, students counselling, Dastak classes (where students can directly meet the principal for any issue), conduct of meetings of PTA, HEIS and Alumni, CCTV monitoring for security, focus on transparency in admission, mentor mentee groups creation, redressal of students' genuine issues, initiatives for overall grooming of students through talent hunt, educational trips, community outreach programmes through NSS, awareness programmes on different burning issues etc.

The overall impact of all such steps has helped the students in getting the top positions in university merit list. IQAC has initiated various practices to maintain college campus eco-friendly through different activities like tree plantation, plastic eradication, clean and lush green campus (Bikram phulwari), save energy (25KW solar power plant), awareness programme on renewable energy (replacing bulbs with LEDs), waste management (pits and best use of waste furniture like selfie stand and tables).

The Equity initiative component of RUSA grant is fairly spent according to the requirement of girl students.

There is provision of CCTV Cameras in the College Campus.

Common room facility is provided to girls. A girls' hostel with good facilities to take care of dwelling needs of girls coming from far off areas is provided.

The college provides all necessary facilities for ensuring equitable opportunities to girl students. Their safety and security in the campus has been ensured by active proctorial duties by the teachers.

GBCC has continued to remain committed in fostering an inclusive environment and to create a fair and equitable space for all staff and students. This is reflected in the fact that more than 90% is female staff and girl students make 63% of the total strength.

The NSS department focuses on gender sensitization through extension lectures, workshops, seminars and awareness rallies. Rallies against Female Foeticide are held, International Women 's Day is celebrated, a seminar on NSS Day with the theme, " Safety of Women", Sanitary pads are distributed to women of slum areas of Patiala. The Red Ribbon Club looks after programs on Aids Awareness. Blood Donation and National Youth Week.

Seminars on 'Elimination of Violence against Women 'are conducted, In charge Traffic Education Cell gives valuable information about 'Domestic Violence Act 2005', 'Anti Sexual Harassment Cell 2013', POCSO Act, cyber safety, traffic education, police help line numbers , availability of Mahila

Mittar. There is a complete waiver of tuition fees for undergraduate girls. Thus, the college is actively engaged in ensuring gender equality.

The college provides all necessary facilities for ensuring equitable opportunities to girl students. Their safety and security in the campus has been ensured by active proctorial duties by the teachers.

The following is the list of National and International Commemorative Days, events and festivals the institute celebrates every year. 7.2.1

Best Practice –I: Participative Management

Objectives:

Participative management and decentralization form the core of college activities and are among the best practices of the institution. The basic purpose is to achieve cooperation in the working of the Principal, college administration, faculty, students and non-teaching staff and to develop an efficient, transparent work culture.

Context:

Government Bikram College of Commerce, Patiala is a Higher education institution with the strength of about 1300 students and 50 staff members providing education in undergraduate and post graduate programs. The practice of participative management is helpful in lessening the load on the Principal so that he/she can concentrate on the general efficiency and effectiveness of college functioning.

Practice:

- The Principal is the head of the college, assigns duties to the staff members by making different working committees. Each committee is headed by a convener and has three members.
- Each Department is assigned an H.O.D, who leads, manages and develops the department to ensure its proper working.
- Each class is divided into sections according to the strength. Each section is assigned an in charge. The in charges build a rapport and provides guidance to the students.
- The Mentor and mentee allotment is done according to the staff-student ratio.
- The college student strength is divided into five houses, which are headed by Mentors.
- There is Library advisory committee that meets every month to discuss issues related to library.

- There is an active PTA (Parent Teacher Association) of the college. The PTA body meetings are held to discuss the important issues.
- GBCC has a registered Alumni Association. The college organizes an annual Alumni meet 'Home Coming'.
- GBCC has an IQAC (Internal Quality Assurance Cell) that meets on first Saturday of every month discussing about the present developments and the future plans.
- GBCC has formed buddy groups to make students aware about ill effects of Drug Abuse.
- There is a provision of Dastak hour, when any student of the college can meet the college Principal regarding any problem.
- The teachers are assigned proctorial duties.
- The College Superintendent leads the non -teaching staff. He works in close collaboration with the Principal and teaching staff to provide necessary support through the non -teaching staff members.
- There is a good practice of involvement of students through their representatives in different college activities.
- The participative management is significant in providing opportunities to students and staff.

Evidence of Success:

The teaching-learning activities are conducted successfully to achieve desired goals. Different college committees and cells put efforts to complete their respective tasks. A large number of co-curricular/extra-curricular and extension activities are organized in planned manner with the active support and participation of the students. The institution provides all requisite facilities, guidance and support system for their holistic development. Thus, this practice is the key to make Government Bikram College of Commerce, Patiala a premier higher educational institution of Punjab

Problems encountered and resources required

The participative management is an excellent administrative tool to handle an institution. It needs strategic planning, active involvement on the part of the college administration and staff.

Best Practice –II: Holistic Development

Government Bikram College of Commerce, Patiala is working with the aim of the holistic development of students to groom them as socially conscious, professionally oriented citizens. The basic aim of all core activities of the college is to provide them facilities and opportunities not only related with academics but also with co-curricular/extra-curricular, activities.

Today's contemporary competitive world demands the total formation of learner's personality. The job markets these days' demand not only students with academic scores but also focus on the soft skills as well as their organizational abilities. The challenge before the college faculty and administration is to provide the best of opportunities to students to help them grow in their distinguished manner.

The various activities are organized by GBCC are contributing in strengthening the holistic development of the students. The aim of the college is to inculcate ethics, social and environmental consciousness among staff and students. The practice involves making the maximum number of students participate in

various activities.

- The shortage of support staff such as sports coaches and musical instructors are major impediments.
- The teachers can only motivate students for the holistic development and create conditions for the same but the successful implementation of this practice requires self-determination and initiative on the part of students.
